SET UP

On the morning of the Festivals, **Vendors must check in between 8am -10am** at the check in area located near the intersection of Main Street and NW 150 Avenue. Please enter Main Street from HWY 441. (Main Street aka NW 141 Street, Alachua 32615). **SET UP MUST BE FINISHED AND VEHICLES PARKED OFF MAIN STREET AND AWAY FROM BOOTHS BY 10 AM.**

TEAR DOWN

Will begin at 5PM and must be completed by 6PM. Please do not dump ice on local lawns, dump on asphalt near sewers. **Vendors are responsible to bag and remove their trash and make sure their booth area is neatly maintained and cleaned.**

GENERAL INFORMATION

- This event is produced by the Alachua Business League.
- **DUPLICATE VENDORS:** WE DO NOT EXCLUDE DUPLICATE VENDORS.

- As this is an outdoor event, rain or shine, fees are non-refundable.
- **You are being provided only the space.** You must bring your own tables, chairs, tents, etc.
- Vendors are responsible for securing tents to the ground. No drilling or damage to pavement can occur. No electricity will be made available.
- Any Vendors using a **generator** must have "whisper working" generator or will be moved.
- Vendors must tape down any and all cords.
- **Political Vendors** are asked to remain at their booths and not walk around soliciting.
- **Charitable Groups** are required to DO an activity with visitors compatible with the festival theme (face or hand painting, balloons, arts/crafts, grab bag, etc.)
- **Rest rooms** located at Skinner Park, Porta-Potties are placed strategically along Main Street.
- **You will receive confirmation by email only. Please provide us with a valid email address on your Registration form.**
